

Part III. Notes for completion

These notes for completion must be read and understood by the certifying officer before signing the certificate. Notes are set out in sections that correspond to the sections in the certificate. By signing this certificate, certifiers are verifying that the consignment meets the requirements set out in the certificate and any relevant corresponding notes for completion.

These notes do not need to be printed as part of a paper certificate that accompanies the consignment or in any electronic copy of the certificate.

References to European Union legislation within this certificate are references to direct EU legislation which has been retained in Great Britain (retained EU law as defined in the European Union (Withdrawal) Act 2018) and can be viewed on the UK legislation website (legislation.gov.uk).

References to Great Britain in this certificate include Channel Islands and Isle of Man.

References to GB requirements refer to the requirement(s) of Great Britain as set out in the accompanying notes for completion.

Part I

- Box reference I.7: Provide name and ISO code of the country or part thereof as appearing in a document relating to 'milk and milk products' published on gov.uk, in accordance with Commission Regulation (EU) No 605/2010 as set out^(†).
- Box reference I.11: Name, address and approval number of the establishment of dispatch. Name of the country of origin which must be the same as the country of export.
- Box reference I.15: Registration number (railway wagons or container and road vehicles), flight number (aircraft) or name (ship). In the case of transport in containers, the total number of containers and their registration number and where there is a serial number of the seal it must be indicated in box I.23. In case of unloading and reloading, the consignor must inform the border control post of introduction into Great Britain.
- Box reference I.19: Use the appropriate Harmonised System (HS) code under the following headings: 04.01; 04.02; 04.03; 04.04; 04.05; 04.06; 15.17; 17.02; 19.01; 21.05; 21.06; 22.02; 28.35; 30.01; 35.01; 35.02; 35.04 or 04.10.
- Box reference I.20: Indicate total gross weight and total net weight.
- Box reference I.23: For containers or boxes, the container number and the seal number (if applicable) should be included.
- Box reference I.28: *Manufacturing plant*: introduce the approval number of the production holding(s). collection centre or standardization centre approved for exportation to Great Britain.

Part II

Animal Health

Raw milk, dairy products, colostrum and colostrum -based products means raw milk, dairy products, colostrum and colostrum-based products for human consumption in transit or storage in accordance with Article 19 of Regulation (EU) 2019/2124.

AH/T300 Territory requirements

The relevant GB animal health standards refers to approved and listed third countries eligible to export milk and milk products to Great Britain in accordance with Regulation (EU) No 605/2010 and can be found on GOV.UK.^(†)

AH/MS002 Product requirements

(a) The model GB health certificates are published on GOV.UK from time to time:

- (b) Include date or dates of production. Imports of raw milk, dairy products, colostrum and colostrum-based products shall not be allowed when obtained either prior to the date of authorisation for exportation to Great Britain of the country or part thereof mentioned under I.7 and I.8 of the certificate, or during a period where restrictive measures have been adopted by Great Britain against imports of raw milk, dairy products, colostrum and colostrum-based products from this country or part thereof.
